#### DALEVILLE AREA CHAMBER OF COMMERCE VENDOR PARTICIPATION AGREEMENT

Vendors participating in DACC events will provide notice 30 days prior to event if unable to attend. Any vendor cancelling participation twice in one calendar year will no longer be eligible to participate in chamber events for the remainder of the calendar year and following year.

Vendors not providing notification to chamber of cancellation will not be eligible to participate in chamber events for the remainder of the calendar year and following year.

Cancellation not received 30 days prior to event will be considered as no notification being provided. In the event of emergencies, the chamber will decide whether to determine eligibility of vendor for future events.
